Influence on positions of power and employment

In my fine art gallery, and I look across the street. There is a flag of Australia on a car, one of the flags of Australia. Australia has three official flags, and I do not doubt they are all official at the moment and used in very official ways.

There is the flag of Australia that speaks to the influence of UK in Australia and English language details.

There is the First Nations Australian Flag, Aboriginal, speaking to thousands of years of understanding of Australia.

Australia has three flags, that are official, and influential and necessary, there shouldn't be doubt about that. Why would the workplace require a sitter from another office, department, or criminal network posing as high security office?
